SUBJECT: MARCH 2026 EMS LOGISTICS DIVISION DELIVERY SCHEDULE

Ambulance Commanders and Captains may request supplies from the EMS Logistics Division monthly, in accordance with their authorized inventory. Only companies whose requests are received on Thursday prior to the date of monthly delivery will receive the deliveries at their firehouse, per the following schedule:

The Senior Ranking Company Officer present at the time of delivery will accept delivery for any other company which is absent from their quarters. Officers receiving supplies from EMS Logistics Division intended for another company in the firehouse will ensure that they are secured and turned over to the Officer of the company which had requested them.

The Company Officer accepting the delivery will inspect and count all items delivered while in the presence of the EMS Logistics Division member. The delivery receipt will be signed by the Company Officer and returned to the EMS Logistics Division member. A copy of the receipt will be left for the Company records.
